

COUNTY CLERK ANNOUNCES EARLY VOTING REQUIREMENTS

Katherine C. Schultz, McHenry County Clerk, announces that voters can cast a ballot prior to the November 4th 2014 General Election as early as October 20th without having to offer a reason or an excuse for wanting to vote early.

The early voting law, effective in Illinois, allows voters to cast a ballot at an early voting center through Sunday, November 2nd.

As all ballot styles, for McHenry County, are available at all Early Voting Centers, voters may choose to vote at the site most convenient for them.

The law prohibits any voter who has been issued an "In Person Absentee Ballot" or "Early Ballot" from appearing at his precinct polling place and requesting another ballot.
