

COUNTY CLERK ANNOUNCES EARLY VOTING REQUIREMENTS

Mary E. McClellan, McHenry County Clerk, announces that voters can cast a ballot prior to the April 7th, 2015 Consolidated Election as early as March 23rd without having to offer a reason or an excuse for wanting to vote early.

The early voting law, effective in Illinois, allows voters to cast a ballot at an early voting center through Saturday, April 4th.

As all ballot styles for McHenry County are available at the below Early Voting Centers, voters may choose to vote at the site most convenient for them.
