**ADMINISTRATIVE ORDER NO. 2015-08**  
**22<sup>ND</sup> JUDICIAL CIRCUIT**  
**McHENRY COUNTY, ILLINOIS**

IT IS ORDERED that all prior Administrative Orders establishing judicial assignments and court calls are hereby vacated and that Corrected Administrative Order No. 2015-08 is effective on JULY 6, 2015.

**CRIMINAL DIVISION**

**Judge Sharon L. Prather – Presiding Judge of the Criminal Division**

**CRIMINAL FELONY I CALL** (Judge Sharon L. Prather – Courtroom 304)

One-half (1/2) of Criminal Felony (CF) and Miscellaneous Remedy (Search Warrants, Rendition, Habeas Corpus (criminal), Eavesdropping, Fugitives from Justice, Forfeitures, and Sexually Violent Person Commitment Act proceedings) (MR), Expungement and Sealing of Criminal Records.

**CRIMINAL FELONY II CALL** (Judge Michael W. Fetterer – Courtroom 302)

**CRIMINAL MISDEMEANOR JURY CALL** (Judge James S. Cowlin – Courtroom 301)

**CRIMINAL MISDEMEANOR DOMESTIC VIOLENCE CASES, MENTAL HEALTH COURT AND DRUG COURT (Judge Charles P. Weech – Courtroom 203)**

Criminal Misdemeanor (CM) involving all domestic violence matters; Domestic Battery; Violations of Orders of Protection; Related Orders of Protection; Interference with reporting Domestic Violence. Mental Health Court and Drug Court proceedings as established by prior Administrative Order.

**CRIMINAL MISDEMEANOR NON-JURY CALL (Judge Joel D. Berg - Courtroom 104)**

Initial return date on all Misdemeanor (CM) (DT) (TR) (CV) (OV) matters (excluding Domestic Battery; Violations of Orders of Protection; Interference with reporting Domestic Violence) from all municipalities and/or State or local law enforcement agencies; all Bench Trials, Summary Suspension Hearings, Judicial Driving Permit proceedings, Forfeitures arising out of CM or DT cases, Petitions to Revoke Proceedings and Bond Hearings.

**TRAFFIC CALL** (Judge Gordon E. Graham – Courtroom 102)

Traffic Violation (TR); Conservation Violation (CV); Ordinance Violation (OV); (CM) Petty Offense.

**SPECIAL ASSIGNMENT** (Criminal/Civil) (Judge Mary H. Nader - Courtroom 357)

Assignment to trials, hearings and other proceedings through case management procedures; vacation and school coverage for Misdemeanor Non-Jury Call, Criminal Misdemeanor Jury Call and Traffic Call. Back-up Courtroom 104 Summary Suspension hearings; and during regular Court hours, the Special Assignment Judge (Criminal/Civil) shall have primary responsibility to respond to requests for assistance by the Court Administration Office during regular Court hours when not actively covering a courtroom. If both the Special Assignment Judge (Criminal/Civil) and the Duty Judge are in court or otherwise unavailable, then it is the responsibility of the other Judges in the Duty Judge Rotation Schedule to respond to requests for assistance from the Court Administration Office. For the purposes of this Administrative Order, regular Court hours are defined as between 8:30 a.m. – 12:00 p.m. and 1:30 p.m. – 4: 30 p.m. each day Court is in session.

**WEEKDAY FIRST APPEARANCE AND BOND COURT** (Rights Courtroom in McHenry County Adult Corrections Facility)

Judges presiding in Criminal Misdemeanor Jury Courtroom 301 and in Criminal Misdemeanor Jury Courtroom 303 are assigned on a rotating schedule kept by Court Administration.

**WEEKEND (SATURDAY) AND COURT HOLIDAY FIRST APPEARANCE AND BOND COURT** (Duty Judge) Rights Courtroom in McHenry County Adult Corrections Facility)

The Duty Judge is assigned on a rotating schedule kept by Court Administration.

**WEEKLY DUTY JUDGE ASSIGNMENT** (Duty Judge)

Outside regular Court hours, the Duty Judge has primary responsibility for handling Emergency Matters, i.e. Search Warrants, Arrest Warrants, Orders of Protection and other Emergency Matters. During regular Court hours, the Duty Judge has secondary responsibility to respond to requests for assistance by the Court Administration Office.

The Duty Judge is assigned on a rotating schedule kept by Court Administration.

**CIVIL DIVISION**

**Judge Michael T. Caldwell – Presiding Judge of the Civil Division**

**CIVIL I COURT CALL** (Judge Michael T. Caldwell – Courtroom 204)

One-half (1/2) of all Eminent Domain (ED); one-half of all Law (claims over \$50,000.00) (LA); one-half of all Miscellaneous Remedy (MR) (except for MR matters assigned to the criminal courts as in this Administrative Order); one-half of all Arbitration Award Rejections of AR and SC cases with jury demands; one-half of all Municipal Corporation (MC); Mandatory Arbitration Supervisor.

**CIVIL II COURT CALL** (Judge Thomas A. Meyer – Courtroom 201)

One-half (1/2) of all Eminent Domain (ED); one-half of all Law (claims over \$50,000.00) (LA); one-half of all Miscellaneous Remedy (MR) (except for MR matters assigned to the criminal courts as stated in this Administrative Order); one-half of all Arbitration Award Rejections of AR and SC cases with jury demands; one-half of all Municipal Corporation (MC); and all Law (claims under \$50,000.00) (LM) with jury demands.

**CIVIL III COURT CALL** (Judge Suzanne C. Mangiamele – Courtroom 358)

Chancery (CH) (all Mortgage Foreclosure cases only).

**CIVIL IV COURT CALL** (Judge John D. Bolger – Courtroom 103)

All Law (claims under \$50,000.00) (Bench) (LM); Small Claims (Bench) (SC); Small Claims Mediation Supervisor; Tax (TX).

**CIVIL V COURT CALL** (Judge Michael J. Chmiel – Courtroom 202)

Mandatory Arbitration (AR) (all pre-arbitration hearing proceedings for all AR cases and SC cases with a jury demand and post-arbitration award rejection proceedings including trials (Bench) in all AR cases without a jury demand); Chancery (CH) (excluding Mortgage Foreclosure cases); Probate (PR).

## **FAMILY DIVISION**

### **Judge Maureen P. McIntyre – Presiding Judge of the Family Division**

#### **FAMILY I CALL (Judge Kevin G. Costello – Courtroom 361)**

One-third (1/3) of Dissolution or Divorce (DV) and Family (FA) (excluding cases relating only to non-support matters initiated by the Office of the Illinois Attorney General).

#### **FAMILY II CALL (Judge Christopher M. Harmon – Courtroom 360)**

One-third (1/3) of Dissolution or Divorce (DV) and Family (FA) (excluding cases relating only to non-support matters initiated by the Office of the Illinois Attorney General); Independent Orders of Protection.

#### **FAMILY III CALL (Judge Mark R. Gerhardt – Courtroom 359)**

One-third (1/3) of Dissolution or Divorce (DV) and Family (FA) (including cases relating only to non-support matters initiated by the Office of the Illinois Attorney General).

#### **SPECIAL ASSIGNMENT (Courtroom 365)**

The Special Assignment Court Call in the Family Division is suspended until further Order of Court.

#### **JUVENILE COURT CALL (Judge Maureen P. McIntyre – Courtroom 101)**


Juvenile Abuse and Neglect (JA); Juvenile Delinquent (JD); Juvenile (JV); Adoption (AD).
