

PERMIT FEE SCHEDULE FOR OVERSIZE AND/OR OVERWEIGHT VEHICLE MOVEMENTS ON THE McHENRY COUNTY HIGHWAY SYSTEM

Effective September 1, 2010

The following fees shall be sufficient to compensate in part for the cost of the extra wear and tear on the mileage of County highways over which the load is to be moved. With respect to over-dimension permits, the fee shall be sufficient to compensate in part for the special privilege of transporting oversize vehicle or vehicle combinations and load and to compensate, in part, for the economic loss of operators of vehicles in regular operation due to inconvenience occasioned by the oversize movements. For more detailed information, refer to the Illinois vehicle Code, Chapter 15 Size, Weight, Load and Permits.

A. LIMITED CONTINUOUS MOVEMENT PERMITS

1. OVERSIZE LOADS

Fees for legal weight but oversize house trailer combinations, modular home sections, roof or floor trusses, or oversize storage buildings in combination with a towing vehicle shall be charged according to the following rates:

Fees for legal weight but oversize vehicles, combinations, and loads other than those described above shall be charged according to the following rates:

2. OVERWEIGHT LOADS

Fees for limited continuous movement of oversize and/or overweight vehicles, combinations, and loads shall be charged \$250 for a quarterly and \$1,000 for an annual permit. Loads up to 12 feet in width, 110 feet in length and of legal height shall be included within this permit. Front tag axle and double tandem trailers are not eligible. The following configurations qualify for the quarterly and annual permits:

- a. 3 or more axles, total gross weight of 68,000 pounds or less, front tandem or axle 21,000 pounds or less, rear tandem 48,000 pounds or less on 2 or 3 axles, 25,000 pounds or less on single axle
- b. 4 or more axles, total gross weight of 76,000 pounds or less, front tandem 44,000 pounds or less on 2 axles, front axle 20,000 pounds or less, rear tandem 44,000 pounds or less on 2 axles and 23,000 pounds or less on single axle or 48,000 pounds or less on 3 axles, 25,000 pounds or less on single axle
- c. 5 or more axles, total gross weight of 100,000 pounds or less, front tandem 48,000 pounds or less on 2 axles, front axle 20,000 pounds or less, 25,000 pounds or less on single axle, rear tandem 48,000 pounds or less on 2 axles, 25,000 pounds or less on single axle
- d. 6 or more axles, total gross weight of 120,000 pounds or less, front tandem 48,000 pounds or less on 2 axles, front axle 20,000 pounds or less, single axle 25,000 pounds or less, or rear tandem 60,000 pounds or less on 3 axles, 21,000 pounds or less on single axles within a tandem.

3. SPECIAL CONDITION

Fees for moving legal size but overweight vehicles, combinations, and loads for the special conditions described below, shall be charged according to the following rates:

Agricultural Commodities	\$5 per axle
Raw Milk	\$12.50 quarterly, \$50 annually

B. OVERWEIGHT AND OVERSIZE LOAD PERMITS

With respect to overweight-gross loads vs. overweight-axle loads, one fee only shall be charged, whichever is the greater, but not both. The overweight fees for the following combinations include an amount for overwidth dimensions of 4 feet or less, overheight and overlength. Any load greater than 12 ft., 6 in. in width shall be charged an additional fee of \$15 for a single trip or \$30 for a round trip.

1. OVERWEIGHT GROSS LOADS

For combinations of vehicles consisting of a 3 axle truck-tractor with a tandem axle composed of 2 consecutive axles drawing a semitrailer or other vehicle, equipped with a tandem axle composed of 3 consecutive axles, the fees shall be charged at the following rates:

For combinations of vehicles consisting of a 3 axle truck-tractor with a tandem axle composed of 2 consecutive axles drawing a semitrailer or other vehicle, equipped with a tandem axle composed of 2 consecutive axles, the fees shall be charged at the following rates:

2. OVERWEIGHT GROSS LOADS for MOBILE CRANE or WATER WELL DRILLING VEHICLE

For a 3 (or more) axle mobile crane or water well-drilling vehicle consisting of a single axle and a tandem axle or 2 tandem axle groups composed of 2 consecutive axles each, with a distance of extreme axles not less than 18 feet, the fees shall be charged at the following rates:

For a 4 (or more) axle mobile crane or water well-drilling vehicle consisting of 2 sets of tandem axles composed of 2 or more consecutive axles each with a distance between extreme axles of not less than 23 feet, the fees shall be charged at the following rates:

For a two axle mobile crane or water well-drilling vehicle consisting of 2 single axles, the fees shall be charged at the following rates:

Fees for special permits to move vehicles, combinations of vehicles and loads with overweight gross loads not included in the above fee categories shall be paid at a rate of \$50 per single trip or \$100 per round trip.

3. LEGAL GROSS WEIGHT WITH OVERWEIGHT AXLE LOADS

Fees for special permits to move legal gross weight vehicles, combinations of vehicles and loads with overweight axle loads shall be paid by the applicant to the County. For each overweight single axle or tandem axle group, the flat rate fees are predicated upon a 20,000 pound single axle equivalency. For axle weights in excess of this amount, the fees shall be charged at the following rates:

C. ENGINEERING INSPECTIONS OR FIELD INVESTIGATIONS

The County may require field investigations, or special engineering investigations requiring assessment of work to be done on the highway and final inspection. The fee for this work will be paid to the County by the applicant at a rate of \$40 per hour.

D. PAYMENT OF FEES

The applicant will receive an invoice that lists the amount owed for the permit. Payments may be made in the form of cash or check. Checks are to be made payable to the McHenry County Division of Transportation. Failure to pay the invoice in full within a 30-day period after the billing date shall be sufficient cause for the County to withhold issuance of any further permits. The County may, at its discretion, charge a service fee of \$3 for a check returned for any reason. All money received by the County shall be deposited in the County Highway Fund (Fund 21). No refund shall be made to an applicant following issuance of a permit if the movement is not completed.

E. AMENDED OR VOIDED PERMIT FEES

Applicants may amend or void an existing permit within one business day after the time of original issuance. The County may collect a fee of \$5 to cover the cost of processing an amendment or voidance to an existing permit. This fee shall be charged for each permit amended or voided. Permits that have been invoiced cannot be amended or voided. Additionally, if the amended permit includes an increase in size or weight or both over that specified in the original permit, additional fees shall be charged as applicable, to correct for the increase.

F. EXEMPTIONS TO PERMIT FEES

Permit fees shall not apply to the owner of the vehicle or vehicle combination if owned by the United States, the State of Illinois, McHenry County or any political subdivision or municipality contained therein.
