PROGRAM OVERVIEW

Members of the LGBTQ community have particular therapeutic needs. Yumi will discuss and focus on increasing the awareness and sensitivity of helping professionals when working with this population.

PROGRAM OBJECTIVES

At the end of the presentation the participant will have gained the following knowledge:

- Identify the unique stressors the LGBTQ communities may experience
- Identify the risks and dangers of assumptions regarding members of the LGBTQ community
- Understand the importance of language and word choice in interfacing with the LGBTQ client

PRESENTER

Yumi E. Terajima Psy.D. is a lead therapist in The Center of Self-Injury Outpatient Program (SIRS) and has been with Alexian Brothers Behavioral Health Hospital for 4 years. She completed her pre-doctoral internship in the SIRS/ED PHP rotation, and stayed on as a post-doctoral intern where she helped implement the After School DBT Skills IOP Program while continuing to work with SIRS. As part of her studies, Dr. Terajima received her LGBT Human Services and Mental Health Certificate from the Rockway Institute at the California School of Professional Psychology and has worked with various members of the LGBTQ communities. Previous trainings and presentation topics have covered tips for transgender client advocacy, education and sensitivity for when working with LGBTQ-identified victims of human trafficking, supporting LGBTQ-identified students, and working with LGBTQ-identified clients.
