Dear Highway Systems Manager:

McHenry County desires to have several Nondedicated Subdivision Roads taken into its jurisdiction to become part of the County Highway system. To that end, the County Board approved certain roads by resolution. In accordance with Highway Jurisdiction Guidelines for Highway and Street Systems, the Highway Systems Manager is the clearinghouse for all jurisdiction issues.

There are over 50 miles of Nondedicated Subdivision Roads in McHenry County. The County desires to take in 23 miles (approximate) initially into its jurisdiction. McHenry County has previously submitted, letter dated October 17, 2016, to the Illinois Department of Transportation (IDOT), for approval, the majority of these roads and is now seeking the Illinois Department of Transportation's (IDOT) approval for the majority of the balance (listing attached) of these initial 23 miles of roads to become part of the County Highway system as it has been determined that they have prescriptive right-of-way.


A few roadways require bridge inspections and once those inspections are complete, these final grouping of roads (of the initial 23 miles) will be submitted to IDOT for review and approval.

It is understood that this is not a typical jurisdictional transfer between two governmental agencies as these Nondedicated Subdivision Roads are privately owned and platted prior to June of 1959. As such, if you need additional information or any other requirements need to be
