

DEE ROAD, a gravel road running East and West, 1240 feet in length with a right of way of 40 feet, bounded on the East by the road commonly known as **DEDLOW ROAD**, and bounded on the West by the road commonly known as **RIVERDALE ROAD**, located in **RIVERDALE SUBDIVISION**, a subdivision of part of the West ½ of the Northeast ¼ of Section 19, Township 44, North Range 9, East of the Third Principal Meridian, North of the Public Highway (except the East 16 ½ feet thereof) according to the Plat thereof recorded July 1, 1924 as Document Number 64254, in Book 4 of Plats, page 117, in McHenry County, Illinois.

JONES AVENUE, a road running East and West, 960 feet in length, with a right of way of 20 feet, bounded on the East by the road commonly known as **BERGMAN ROAD** and on the West by the road commonly known as **RIVERDALE ROAD**, located in **RIVERDALE SUBDIVISION**, a subdivision of part of the West ½ of the Northeast ¼ of Section 19, Township 44, North Range 9, East of the Third Principal Meridian, North of the Public Highway (except the East 16 ½ feet thereof) according to the Plat thereof recorded July 1, 1924 as Document Number 64254, in Book 4 of Plats, page 117, in McHenry County, Illinois.

BERGMAN DRIVE, a road running North and South, 520 feet in length, with a right of way of 40 feet, bounded on the North by the road commonly known as **DEE ROAD**, and on the South by the road commonly known as **WAUCONDA ROAD**, located in **RIVERDALE SUBDIVISION**, a subdivision of part of the West ½ of the Northeast ¼ of Section 19, Township 44, North Range 9, East of the Third Principal Meridian, North of the Public Highway (except the East 16 ½ feet thereof) according to the Plat thereof recorded July 1, 1924 as Document Number 64254, in Book 4 of Plats, page 117, in McHenry County, Illinois.

DEDLOW ROAD, a road running North and South, 260 feet in length, with a right of way of 40 feet, bounded on the North by the road commonly known as **DEE ROAD**, and on the South by the road commonly known as **WAUCODA ROAD**, located in **RIVERDALE SUBDIVISION**, a subdivision of part of the West ½ of the Northeast ¼ of Section 19, Township 44, North Range 9, East of the Third Principal Meridian, North of the Public Highway (except the East 16 ½ feet thereof) according to the Plat thereof recorded July 1, 1924 as Document Number 64254, in Book 4 of Plats, page 117, in McHenry County, Illinois.

RIVERDALE ROAD, a road running North and South, 1900 feet in length with a right of way of 40 feet, bounded on the South by the road commonly known as WAUCONDA ROAD, and to the North by the road commonly known as JONES AVENUE, located in RIVERDALE SUBDIVISION, a subdivision of part of the West ½ of the Northeast ¼ of Section 19, Township 44, North Range 9, East of the Third Principal Meridian, North of the Public Highway (except the East 16 ½ feet thereof) according to the Plat thereof recorded July 1, 1924 as Document Number 64254, in Book 4 of Plats, page 117, in McHenry County, Illinois.

BERGMAN DRIVE, a road running North and South, 363 feet in length with a right of way of 60 feet, bounded on the South by the road commonly known as JONES AVENUE, and on the North by the road commonly known as POOL STREET, located in Griswold Lake Lagoon Subdivision, a subdivision of part of the Southwest quarter of the fractional Southeast quarter of Section 18, Township 44, North Range 9, East of the 3rd Principal Meridian according to the Plat recorded June 15, 1942 as document number 163566.

POOL STREET, an L shaped street 469 feet in length with a right of way of 60 feet, bounded on the East by the road commonly known as BERGMAN ROAD, and on the South by the road commonly known as JONES AVENUE, located in Griswold Lake Lagoon Subdivision, a subdivision of part of the Southwest quarter of the fractional Southeast quarter of Section 18, Township 44, North Range 9, East of the 3rd Principal Meridian according to the Plat recorded June 15, 1942 as document number 163566.
