PROGRAM OVERVIEW

This workshop will focus on providing mental health clinicians and supervisors with information they need to provide clinical services and support to adults, children and adolescents who have been exposed to domestic violence.

- Understand how domestic violence affects parenting and provide skills for parents who have lived with abuse
- Know mandated reporting requirements for domestic violence situations
- Know when to refer to a domestic violence agency
- Develop multicultural competency related to domestic violence

Jane Zamudio is the Associate Director of Turning Point, Inc., the only domestic violence agency and shelter in McHenry County. Jane has worked in direct service in the domestic violence field, providing case management, counseling and psychotherapy to adult and child victims of abuse. She has also worked in administrative roles including as Coordinator of Turning Point's emergency shelter. She currently supervises all of Turning Point's victim programs. Jane also provides education to the community in the 40-hour domestic violence training offered by Turning Point. Jane has a Master's Degree in Community Counseling, is a Licensed Clinical Professional Counselor and an Illinois Certified Domestic Violence Professional.

Arti Persaud is the Mental Health Coordinator at Turning Point Inc. where she provides mental health therapy to both adults and children who have experienced domestic violence.
