At this time, we cannot accept this roadway into McHenry Township Road District because of the current condition of the roadway. Based on this, the petitioners would request that the roadway described in Exhibit "A" be accepted into the County Non-Dedicated Subdivision Road Construction program. As a matter of clarification, this roadway is not included in Resolution R-106-8-82-192.

Should the roadway be accepted into the referenced program and improved to an agreed upon standard, McHenry Township Road District will accept the roadway into the Township Roadway System.



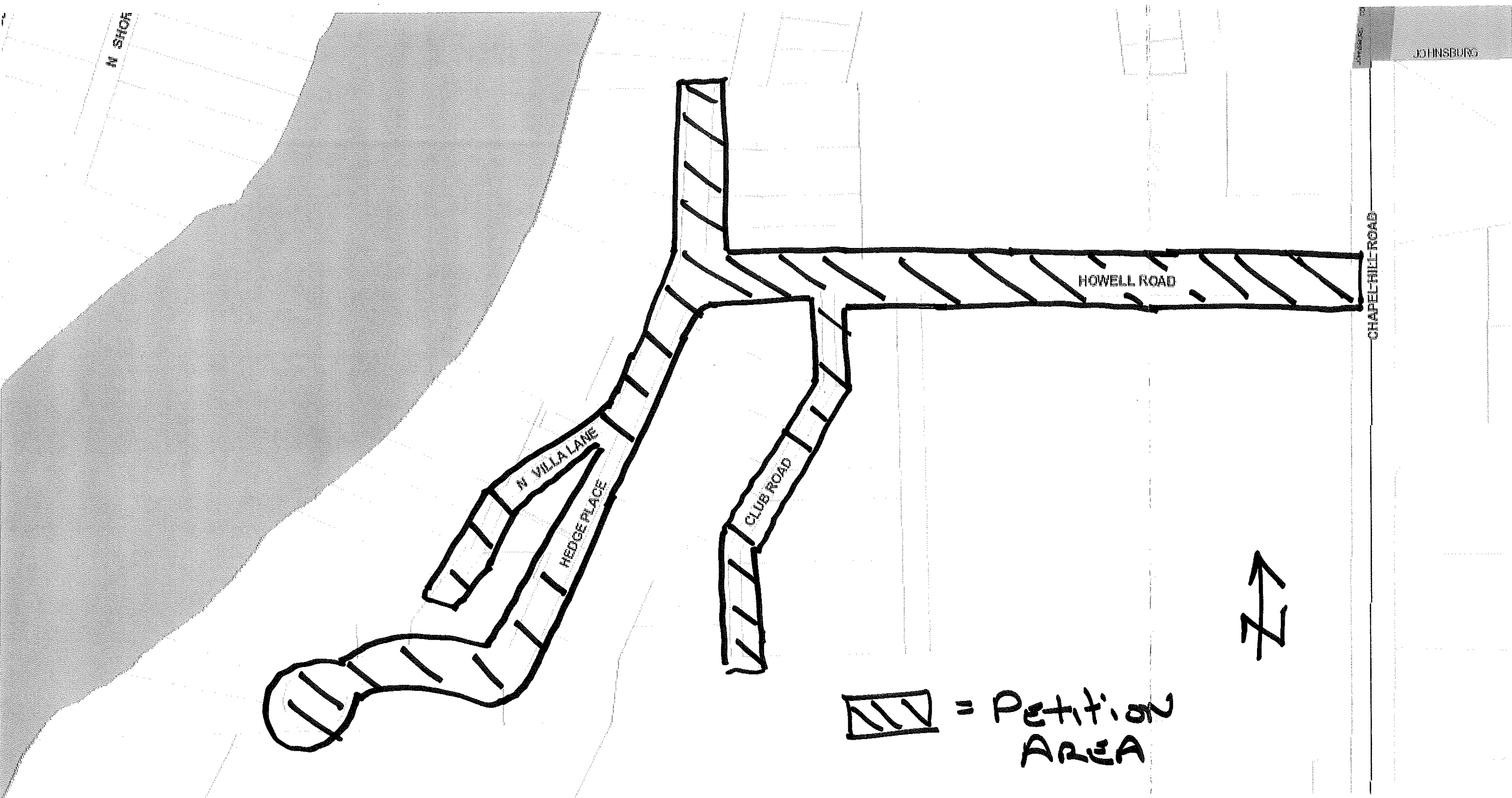
