Based on this, the petitioners would request that the roadway described in Exhibit "A" be accepted into the County Non-Dedicated Subdivision Road Construction program. As a matter of clarification, this roadway is not included in Resolution R-106-8-82-192.

Should the roadway be accepted into the referenced program and improved to an agreed upon standard, McHenry Township Road District will accept the roadway into the Township Roadway System.

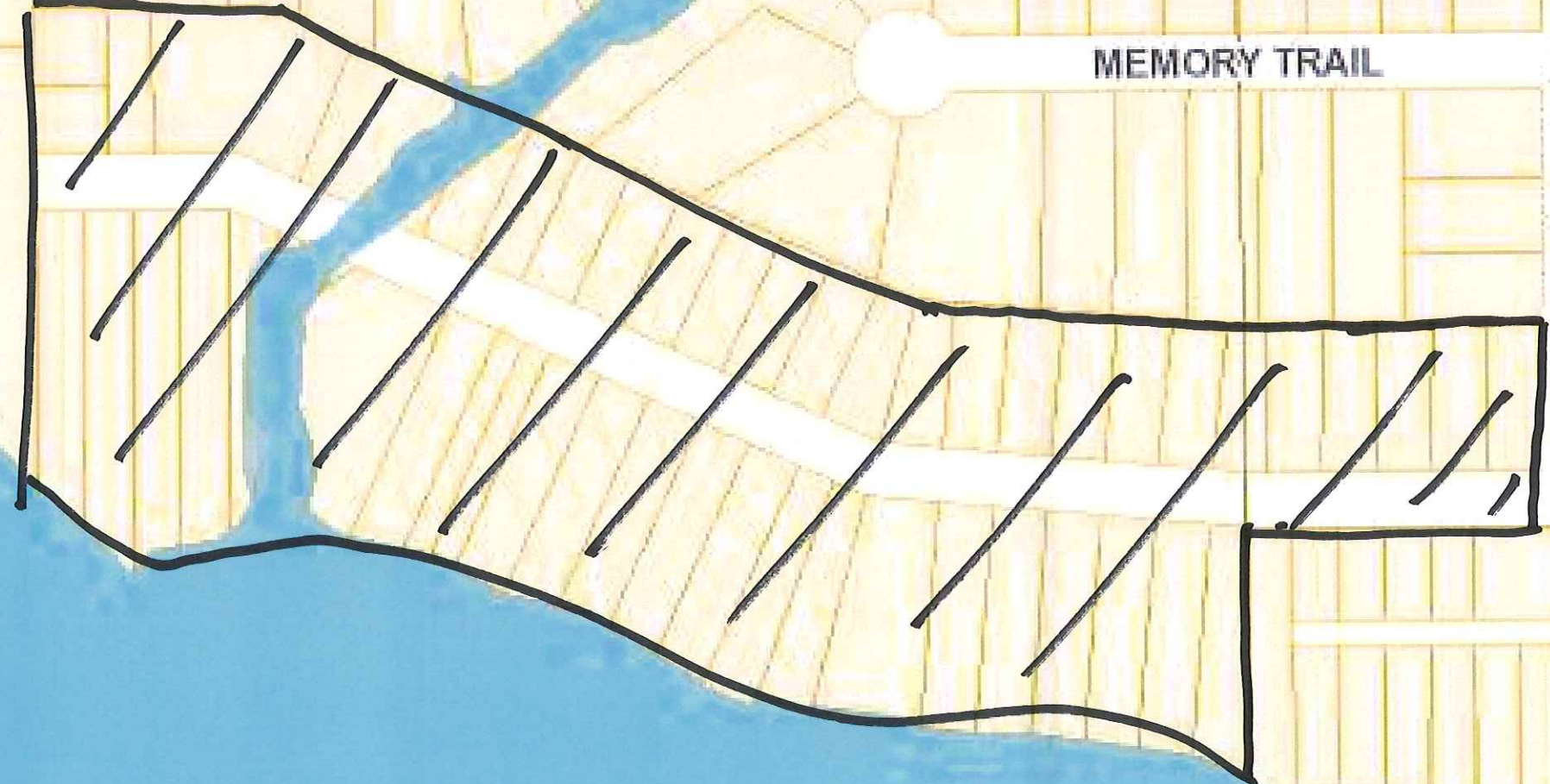
