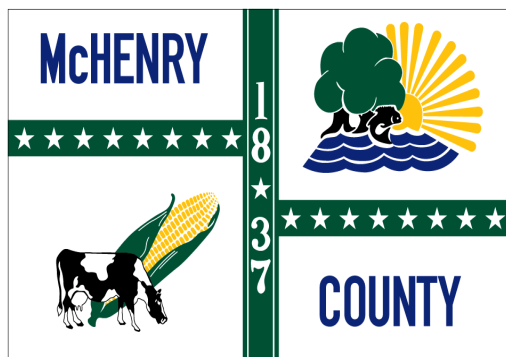


## Water Resources Division

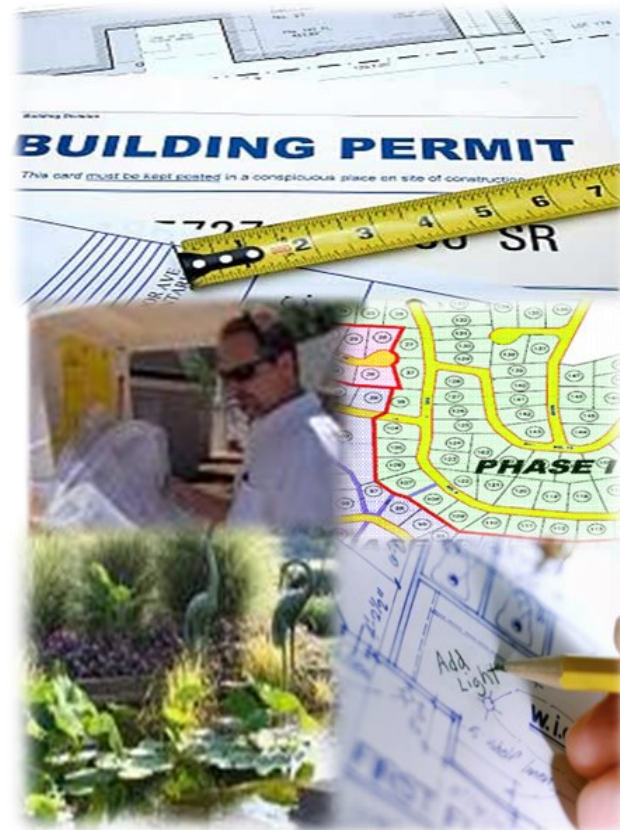
Division staff responds to concerns regarding site grading, flooding, drainage, and wetlands. Staff enforces the Stormwater Management Ordinance and assists property owners in obtaining stormwater management permits. They also inspect development sites and review subdivision engineering plans.

This Division also works to preserve and protect the quantity and quality of groundwater, which is the sole source of potable water for McHenry County. The Water Resources Manager facilitates development and implementation of the water Resources Action Plan, education and outreach water conservation programs and scientific research.

Administration supports the department's personnel, provides initial customer service, schedules inspections, responds to requests for information, and maintains permit files. Staff also supports various County committees and commissions by preparing and distributing agendas and transcribing minutes.

## Community Development Division

Community Development is responsible for administering U.S. Department of Housing and Urban Development (HUD) grant programs including the Community Development Block Grant (CDBG), Housing and Investment Partnership (HOME), and Neighborhood Stabilization Program (NSP). Staff prepares all federally mandated plans and reports. Staff serves as liaison to the CDBG Commission, the Housing Commission, and the Continuum of Care Committee.

## Permitting Division

PIE staff assist property owners, developers and contractors with their construction projects from the beginning stage to completion. The Division is responsible for enforcement of the County's adopted Building Codes, Sign Ordinance, and Zoning Ordinance.

## Planning Division

This division is responsible for long range planning, sub-area planning, and special studies. The Division processes zoning petitions and facilitates the subdivision review process. The Division also provides the Department's GIS mapping and graphics support.
