



## PlanDev Viewer Interactive Map: Instructions for determining municipal jurisdiction:


1. Open the map. Click OK to clear the disclaimer notice.
2. Enter the PIN or address (it should auto-fill as you type) in the “Search By” field.
  - a. If you used the PIN, it will display preliminary “Results” and select the parcel.
  - b. If you used the address, it puts a selection “donut” about where that is; then--
    - 1) Click the Property Info button. (You may need to close the Results box first).
    - 2) Then click or drag on the parcel(s) – it will display as in 2.a.
3. If the parcel is in a municipality, it will be shaded (various colors), or scroll all the way to the right in the “Results” box to “Incorporated” (Yes or No).
4. If “Yes” is found in this field, to find out which municipality, click the “Show Details” button in the Results box.
  - a. Click the “Tax Info” tab.
  - b. Scroll down and look for [name of] City or [name of] Village. If it shows paying taxes one of those, that is the municipality in which the parcel is located.
5. Go to the “[Local Agencies and Related Links](#)” page for contact information.
