Between May 1st 2026 and May 4, 2026: The McHenry County Continuum of Care to End Homelessness the Ranking Work group and Community Development Staff will review Letters of Intent and compile information from said review. The McHenry County Continuum of Care to End Homelessness the ranking work group will make recommendations for funding through an email vote; recommendations will be forwarded to the full Continuum of Care for further consideration.

May 4, 2026 at 9:00 am CDT: The McHenry County Continuum of Care to End Homelessness Full Board will participate in an electronic voting to consider the funding recommendations

An organization allocated funding can expect the following:

1. An application to be submitted to the State of Illinois for funding.
2. Completing some additional information for the master CoC application to the State of Illinois
3. Reporting, as required and stipulated by the State of Illinois
4. Program monitoring, if applicable, by the State of Illinois

2. Program Description

The Illinois Department of Human Services Prevention funding provides support to organizations helping McHenry County residents avoid homelessness. There are no designated priority activities for this funding. Support is flexible, and allows for activities in the following categories:

R = Rent Assistance/Arrearage

U= Utility Assistance/Arrearage

CM= Case Management Services

M= Mortgage Assistance/Arrearage

SD= Security Deposit Assistance

SS= Supportive Services (Legal Services Only)

The Ranking work group of the McHenry County Continuum of Care to End Homelessness anticipates awarding applicants based on prior grant experience (if applicable), cost per client, general organizational outcomes and anticipated number of clients served with funding.

5. Collaboration

The McHenry County Continuum of Care to End Homelessness encourages applicants to consider a collaboration to assist in the rollout of homelessness prevention services in the community.

6. Final Funding Allotment

The McHenry County Continuum of Care to End Homelessness reserves the right to reduce or increase allocations or consolidate or eliminate projects based on the final award to McHenry County.
